How We Calculate Your Variable APR's: Variable APR's are based on the Prime Rate and are accurate as of December 11, 2025. Unless an introductory APR is in effect, we will add a “Margin” to the Prime Rate to determine your standard variable APR. For each billing period we will use the Prime Rate published in the Wall Street Journal as of the last business days of each month. The “Margin” for purchases, balance transfers and cash advances will be 12.00% to 18.00% percentage points, based on your creditworthiness.
